BAC Resolution No. 17 (S. 2022)

“DECLARING FAILURE OF THE BIDDING FOR THE PROCUREMENT OF
BRAND NEW NEDA7 ICT EQUIPMENT UNDER MITHI FUND – **LOT 2**”

WHEREAS, the NEDA Regional Office VII, on 29 September 2022, posted the Invitation to Bid for the Procurement of Brand New NEDA7 ICT Equipment under MITHI Fund, comprising of 3 Lots, in the PhilGEPS website, NEDA VII website and at a conspicuous place within the premises of the NEDA Regional Office VII, Sudlon, Lahug, Cebu City;

WHEREAS, in response to the posting, the BAC received one bid from the Mustard Seed Systems Corporation (MSSC) before the deadline of submission of bids, which is on 24 October 2022, 12:00 NN;

WHEREAS, the bid includes a proposal for Lot 2 which requires the delivery of 6 brand new and functional Laser Printers;

WHEREAS, during the bid opening and preliminary examination held last 24 October 2022, 1:00 PM, the bid documents submitted by MSSC met the eligibility, technical and financial documents required;

WHEREAS, the bid amount proposed by MSSC for Lot 2 is Php351,000.00 which is within the ABC of Php360,000.00;

WHEREAS, upon detailed evaluation of the documents submitted, the BAC confirmed the Secretariat's finding that the laser printer being offered by MSSC did not meet the required specification on paper sizes;

NOW THEREFORE, BE IT RESOLVED, to declare failure of the bidding for the Procurement of Brand New NEDA7 ICT Equipment under MITHI Fund - Lot 2 because the laser printer being offered did not meet the required specification on paper size;

RESOLVED FURTHER, to notify MSSC that their bid for Lot 2 was rejected by the BAC;

RESOLVED FINALLY, to attach the highlights of the BAC meetings for the opening of bids (24 October 2022) and the detailed evaluation (26 October 2022) as an integral part of this resolution.
