BAC Resolution No. 18 (S. 2022)

**“DECLARING THE BID OF MUSTARD SEED SYSTEMS CORPORATION (MSSC) AS THE SINGLE CALCULATED and RESPONSIVE BID (SCRB) FOR THE PROCUREMENT OF BRAND NEW NEDA7 ICT EQUIPMENT UNDER MITHI FUND - LOTS 1 AND 3”**

WHEREAS, the BAC, during its meeting last 26 October 2022, declared the bid of Mustard Seed Systems Corporation (MSSC) for the Procurement of Brand New NEDA7 ICT Equipment under MITHI Fund- **Lot 1** (22 WAPs and 1 Security Gateway, 1 Network Switch and 2 UPS); and **Lot 3** (1 Laser Projector) as the Single Calculated Bid (SCB);

WHEREAS, the end-user unit with the assistance of the Secretariat, conducted a post qualification of the bid of the MSSC through the following:

1. Requested MSSC confirmation with additional supporting documents of the following specifications as per BAC instruction:

2. Requested MSSC for the latest copy of the income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS); and,
3. Interviewed MSSC’s client with ongoing contract.

WHEREAS, based on the post qualification report presented, the BAC found the bid of MSSC for Lots 1 and 3 to be responsive to the requirements;

NOW THEREFORE, BE IT RESOLVED, to declare the bid of MSSC for the Procurement of Brand New NEDA7 ICT Equipment under MITHI Fund- **Lot 1** (22 WAPs and 1 Security Gateway, 1 Network Switch and 2 UPS) with bid amount of **PhP857,796.00** ; and **Lot 3** (1 Laser Projector) with bid amount of **PhP272,000.00** as the Single Calculated and Responsive Bid (SCRB);

RESOLVED FURTHER, to recommend to the OIC - Regional Director of NEDA7, the Head of Procuring Entity, the award of the contract to MSSC for the Procurement of Brand New NEDA7 ICT Equipment under MITHI Fund – **Lots 1 and 3**;

RESOLVED FINALLY, to attach the highlights of the BAC meeting for the post qualification last 27 October 2022 as an integral part of this resolution.


